#### The Louisiana Senate Bill 549 Story

On May 19, 2010, the Louisiana Senate Commerce, Consumer Protection, and International Affairs Committee killed Senate Bill 549. Senator Robert Adley, R-Benton, introduced the bill at the Louisiana Chemical Association's (LCA's) behest to try to force Tulane University to shut down TELC in return for continued state funding. Tulane and Loyola Universities, students, clients, alumni, and clinical faculty from all the state's law schools worked—with help from the Clinical Legal Education Association, the Society of American Law Teachers, the American Association of Law Schools, the Louisiana State Bar Association, the ABA, and many others—to publicize clinics' roles in legal education and expanding access to the legal system. At the May 19 hearing, Tulane University President Scott Cowen testified that if Tulane were to shut down its clinics to preserve state funding under Bill 549, "we [would] throw under the bus every indigent person in this state ... and say we will not represent you because the money is more important. That does not happen in America." On May 24, 2010, New Orleans CityBusiness editorialized: "By attempting to snuff [TELC's] existence, Adley and the LCA were, in effect, thumbing their noses at the law, judicial process and regulation .... Lawmakers deserve commendation for helping the bill meet its demise."
