In early 2018, <u>The Art of the Northern Renaissance: Courts, Commerce and Devotion</u> by **Stephanie Porras**, Assistant Professor of Art History, will be published by Laurence King. The book will be launched at the Annual Meeting of the College Art Association in Los Angeles.

Sam Ramer, Associate Professor of History, was an invited to participant in a conference and celebration marking

the 30th anniversary of the Russian poet Joseph Brodsky's award of the Nobel Prize in Literature. The conference and accompanying public celebration took place in St. Petersburg, Russia on December 10, 2017. At the conference, which took place at Joseph Brodsky's St. Petersburg apartment, now a museum, Ramer presented a paper entitled "Joseph Brodsky and American Society." He also spoke at the much larger public celebration on the evening of the same day. This celebration, with an audience of about 200 people, took place in the auditorium of the Hermitage Museum. The Hermitage is attached to the Winter Palace, the residence of Russia's tsars. Speaking in Russian to a Russian audience there understandably had a special significance for Professor Ramer. Chris Rodning, Paul and Debra Gibbons Professor in the Department of Anthropology, recently participated in the 2018 annual conference of the Society for Historical Archaeology in downtown New Orleans, where he gave a paper about early contacts between Spanish conquistadors and colonists and Native Americans of western North Carolina during the sixteenth century, and with help from Tulane graduate students, installed a display about the Tulane Center for Archaeology at the annual SHA public archaeology day event that took place in the Jazz Museum at the Old U.S. Mint.

**Toby Wikström,** Assistant Professor of French, gave the paper "Displacing the Sixteenth/Seventeenth-Century Divide: Towards an Alternate Periodization of Early Modern French Tragedy" at the roundtable "The Sixteenth/Seventeenth-Century Divide in French" and chaired the panel "Current Trends in Seventeenth-Century French Studies" at the Modern Language Association's annual convention in January 2018. He also began his five-year term as an elected member of the MLA's Executive Committee for the Seventeenth-Century French Forum.
